**CLASSIFICATION OF MEMBERSHIP:**

*Regular Voting Member of the Institute: A Member will have an active part in supporting and utilizing the programs and activities of the CTIOA, Inc. and will be entitled to one vote at the annual membership meeting. A Member must be from one of the two Industry Groups listed below.*

*Contractors: Any Company, as defined below, who is a duly licensed ceramic tile contractor.*

*Manufacturer/Distributor: Any Company, as defined below, whose principal line of business involves manufacturing or distribution of ceramic tile, or allied products or services to the ceramic tile industry, including, but not limited to, ceramic tile manufacturers, allied product manufacturers, ceramic tile distributors and ceramic tile importers.*

*Associate (Non-Voting) Member of the Institute:*

*Associate: Any individual or organization who wish to support the Tile Industry at a more modest level. Associate Memberships are also available to individual employees of members, retired contractors or professionals, and other interested individuals or groups.*

*For purposes of determining membership eligibility, a "Company" shall mean any sole proprietor, partnership, corporation, or other legal entity.*

**DESIGNATED AGENT:**

*Designated Agent -- Each member shall designate in writing to the corporation its agent or representative who shall be deemed the person recognized by the corporation as the member for all purposes of the corporation and its affairs. Each member may designate only one agent or representative and each member shall have the right to change its agent or representative as often as it so chooses by communicating that change in writing to the corporation.*
